

TERMS AND CONDITIONS OF EARLY BIRD PARKING AVAILABILITY CARD (“CARD”)
THE UNIVERSITY OF AUCKLAND

1. The payment for the Card and holding of the Card by a qualified holder provides an opportunity for use and, not a guarantee of, EARLY BIRD PARKING in the University’s Owen G Glenn Building car park. (“OGGB Car Park”).
2. The Card must be paid for when it is uplifted and is conditional on the holder of the Card supplying sufficient current information to the University to meet qualifying staff and student criteria. For staff, this condition can be met by production of your current UoA identity card. For students this condition can be met by production of proof of your enrolment as a full time student in the current semester.
3. Use of the Card will be for a period of one year. There are no refunds or part-year payments or refunds. The fee for the Card shall be advised from time to time by the Registrar of the University.
4. The Card is issued subject to the holder remaining a qualifying staff member or student of the University and must be returned immediately such qualifying staff member or student leaves the University. The Card remains the property of the University at all times.
5. EARLY BIRD PARKING shall mean such parking as is available at the discretion of the University to the qualifying holder of a card who shall enter the OGGB Car Park no later than 10am on a day when the OGGB Car Park is open for such parking, and who shall depart from the OGGB Car Park no later than 11:30pm on that day, the holder paying the EARLY BIRD PARKING fee from time to time set by the Registrar and on display at the OGGB Car Park.
6. EARLY BIRD PARKING is neither guaranteed as available on any one day nor during days when the OGGB Car Park is closed.
7. The Card, and use of the OGGB Car Park, are subject to all directions signs and requirement of the University including those erected inside or outside the OGGB Car Park, including limitations on the liability of the University.
8. Cards shall not be lent to or assigned to or sold to or in any way used by anyone other than the card-holder who was the applicant for that card.
9. Cards may, at the discretion of the University, be offered for re-issue on an annual basis, subject to payment of the annual fee established from time to time, and the terms of issue then applicable. There is no guarantee that a card (or any cards) will be re-issued, or available for longer than the year of issue.

10. The University takes no responsibility for loss or damage to vehicles, or property in them, whilst on its premises.
11. The University operates a tow-away policy where vehicles are illegally parked or parked contrary to signs and requirements at the OGGB Car Park, and/or if these terms and conditions are breached by the card-holder.
12. If a card-holder is on reasonable grounds found to be in breach of these conditions or in breach of the signs and requirements referred to above, the University may without notice cancel the card and require its return without notice and without any fee refund and without prejudice seek recompense or damages from a card-holder who has caused damage to the University arising out of such a breach.
13. THIS IS NOT A PARKING PERMIT. IT IS THE ABILITY TO ACCESS EARLY BIRD PARKING AS AND WHEN AVAILABLE. THE CARD IDENTIFIES THE HOLDER AT THE CASH MACHINE AS AN EARLY BIRD PARKER SO THE EARLY BIRD FEE (CASH OR CREDIT CARD) IS PAYABLE.
