## **Author Guidelines**

The First Years Ngā Tau Tuatahi is a professional journal for people involved and interested in the education and care of infants and toddlers. It is a peer reviewed journal, including two types of articles: one quality assured by engagement with the editor, the other quality assured through double blind-peer review by two reviewers.

Authors are invited to submit manuscripts under the following categories:

Research-based article/report

Reflective/opinion piece

Book review

Voices from the field/interviews

### **General Information**

- The word count for research-based articles/reports and reflective/opinion pieces is 1500-4500 words. The word count includes the abstract, tables, and references.
- The word count for a book review is 1000-1500 words. Book reviews highlight key features and themes and demonstrate the relevance of the book's content to infant and toddler care and education/research. Reviews usually discuss each of a book's chapters in succession, but alternative formats will be considered.
- Manuscripts are to be submitted to the Editors Collective as Word documents attached in an email sent to <a href="mailto:firstyearsjournal@auckland.ac.nz">firstyearsjournal@auckland.ac.nz</a>
- When you submit your manuscript, indicate whether your preference is for the manuscript to be reviewed by the editor or blind peer reviewed by two reviewers.
- Before submitting your manuscript, read the following guidelines. Submissions that do not align with these may be returned to the authors for further attention.

#### Format Guidelines:

- *Format*. Submit your manuscript as a Word document with 2.5 cm margins. Use Times New Roman font, size 12, for the main text and double-space the lines.
- *Headings and subheadings*. The main title should be size 16. Subheading should be size 12. Both the main title and subheading should be in bold and the first letter of each word than contains more than four letters should be capitalised.
- *Paragraphs*. Instead of indenting the beginning of a line to indicate a new paragraph, leave a line to create a space between paragraphs.

- *Referencing*. Articles submitted for publication are expected to be supported by relevant academic and professional literature using APA guidelines (7th edition). This includes providing a reference list at the end of your manuscript in alphabetical order with URLs if available. Refer to the referencing examples provided after these Author Guidelines.
- Grammar and Spelling. Before submitting material, ensure it is grammatically correct and you have done a full spell check set to New Zealand English. Check that words in te reo Māori and other languages are spelled correctly.
- *Images*. Colour images are preferred. Supply these separately in JPEG format (resolution of 300dpi or higher) and indicate where you intend them to be placed in the text. Include a short caption underneath each image.
- *Charts and Diagrams*. Supply these separately and indicate where you intend them to be placed in the text. Include a short caption underneath each chart or diagram.

# **Submission Preparation Checklist**

In addition to the format guidelines above, check that your manuscript complies with the following before submitting it to the Editors Collective:

- 1. The submission has not been previously published, nor is it currently submitted to another journal for consideration
- 2. You have permission to use the images included.
- 3. If you are submitting for peer review, attach a second copy of your manuscript in which the author or authors' names are anonymous. Do this by replacing the name of the author with the word "Author". Use "Author 1, Author 2" etc. if there are multiple authors. This includes any in-text reference to other work by the author/s and the reference list. With Microsoft Office documents, author identification should also be removed from the properties for the file. To do this in Microsoft Word, see Prepare and Inspect Document. To do this on a MacBook word doc, see File/Properties/Summary).

When your manuscript is ready, submit it to the Editors Collective at <a href="mailto:firstyearsjournal@auckland.ac.nz">firstyearsjournal@auckland.ac.nz</a>. Receipt of manuscripts will be acknowledged by email.
