# Bachelor of Laws (LLB)

## Background

The LLB does not require specific school subjects for your admission into Part I, but we recommend subjects that focus on linguistics and essay writing skills. Subjects that promote your oral and critical thinking skills are also useful. You may consider the following school subjects: Classical Studies, Economics, English, Geography, History, History of Art, Languages, Te Reo Māori, Te Reo Rangatira.

From music gigs to overseas travel, Sione Roberts made the most of university life, but it was his focus on Māori and Pacific legal perspectives that gave his studies real purpose.

Growing up in Hawke's Bay, Sione loved music and sport but admits school was a "mixed bag" until he set himself the challenge of giving his best to every subject. That decision carried him through a conjoint Law and Music degree while performing in bands, debating, travelling, and modelling for brands like Zambesi and Hallensteins.

"One of my key reasons for studying Law was to understand how the law has caused inter-generational harm to Māori, and how we, as Māori lawyers, can change the law."

Courses in te ao Māori and Pacific perspectives were the most enriching part of his studies. South Pacific Legal Studies revealed how Samoa's legal system has shaped the LGBTQIA+ community, while Pacific Music and Dance connected him to his Māori and Samoan whakapapa.

# LLB conjoint degree structure

**Conjoint degrees enable you to complete the requirements of two degrees simultaneously, only adding one year of study to the longest degree in most cases. Admission can be in the first year or at any point before you have passed no more than 270 points for either component degree. Continuation depends on you maintaining your academic record to a set standard.**

(iii) If you're planning a 60-point or 120-point Law Exchange in your final year, you may need to adjust your degree structure and consider Summer School courses.

## Conjoint combinations

### **Bachelor of Arts/Bachelor of Laws**

The BA/LLB lets you choose from a wide range of subjects offered by the faculties of Arts and Education and Law. You can create your own combination of subjects, provided they comply with the course regulations of both degrees.

### **Bachelor of Commerce/Bachelor of Laws**

If you intend to practice in commercial, taxation and company areas, then a BCom/LLB is an excellent choice. You will also gain a broad background suitable for a position in management or public administration.

### **Bachelor of Communication/Bachelor of Laws**

With the BC/LLB conjoint you'll gain an understanding of the roles communication and law have in our world, along with the ability to navigate these specialised areas.

### **Bachelor of Global Studies/Bachelor of Laws**

With a BGlobalSt/LLB conjoint, you can complement your legal skills and knowledge with the study of global issues. This will help you to take on the challenges of global politics, law and human security.

### **Bachelor of Health Sciences/Bachelor of Laws**

The BHSc/LLB offers you a sound introduction to law and the healthcare sector. This could lead to a career in medical law, health policy, health management or healthcare ethics.

### **Bachelor of Music/Bachelor of Laws**

If you want a degree that provides you with two distinct skill sets, the BMus/LLB is an excellent choice. Follow your passion for music while growing valuable analytical, communication and research skills – and gain an understanding of legal ethics, professional responsibility and the role law plays in society.

### **Bachelor of Science/Bachelor of Laws**

If you have an aptitude for science, a conjoint BSc/LLB degree gives you an excellent opportunity to construct a programme of study that can lead to a career in environmental law, intellectual property law, or science.

There is considerable flexibility in planning conjoint programmes. The sample LLB conjoint degree structure opposite is only one of several possible plans.

# The application and enrolment process

1

## Apply online

Go to [auckland.ac.nz/applynow](http://auckland.ac.nz/applynow) and complete the online Application to Study form.

- Select 'Bachelors' as your programme type.
- Choose 'Bachelor of Laws' as your programme.
- For Major/Specialisation select 'Law Part I'.

2

## Apply for a non-Law degree and a conjoint programme

This step is essential. Once you have applied for your LLB, you must also apply for:

- A standalone non-Law bachelors degree, and
- The conjoint degree that combines Law with your chosen non-Law programme.

Admission to a conjoint programme has higher entry requirements. We strongly recommend submitting all three applications as a backup.

## Submit requested information

Provide personal information, transcripts, and any other documents required.

4

## Receive offer of place

Your LLB Part I application will be assessed once your other degree applications are in. Decisions are usually released in mid-January.

- You may receive single-degree offers before your conjoint decision.

5

## Accept your offer of place

Please make sure to formally accept your offer for the degree programme as soon as possible. If later you receive a conjoint offer, you can switch by contacting a Student Hub.



# Entry requirements



**Auckland Law School welcomes aspiring legal minds with accessible entry pathways and world-class opportunities. If you gain University Entrance, you're already on track to begin your journey in law.**

## University Entrance

To be admitted, you must have University Entrance (UE):

- NCEA Level 3
- 14 credits at Level 3 in each of three approved subjects
- Literacy: 10 credits at Level 2 or above
- Numeracy: 10 credits at Level 1 or above

## LLB Part II

Admission to LLB Part II is selective and based on academic merit.

To be considered, you must have:

- Passed LAW 121G Law and Society
- Passed LAW 131 Legal Method and LAW 141 Legal Foundations with at least a C+ in each course
- Passed at least 75 points (or the equivalent) of non-law courses
- Achieved a minimum LawGPA of 3.00 (C+)

Selection is based on your LawGPA, which includes grades from Law and non-Law courses.

Recent entry LawGPAs have ranged between a GPA of 5.0 and 7.0 (equivalent to a grade between B and A-).

## Academic English Language Requirement (AELR)

All undergraduate students must meet the AELR to ensure they have the academic English skills needed for study success.

If you haven't met AELR through your school qualification, you can complete an approved course in your first year.

## International Students

If English is not your first language, you must provide evidence of English-language proficiency.

For LLB Part I, this can be shown by:

- An IELTS (Academic) score of 6.0 overall, with no band less than 5.5, or equivalent

or

- Completion of the Foundation Certificate in English for Academic Purposes (FCertEAP) or EPUS programme

For direct entry into LLB Part II, graduates must have an IELTS score of 7.0 overall, with no band less than 6.0.
