GUIDE TO PROTOCOL DEVIATIONS & WITHDRAWALS PART ONE

Do you know when to report protocol deviations and withdrawals?

We have created a dedicated column in this month's and next month's newsletter to provide tips on reporting and managing protocol deviations and withdrawals.

Protocol Deviations (Complete CRF 11)

Type of Protocol Deviation	Example			
Randomised in error	 Randomised not eligible participant Randomised before receiving written consent, then later changed their mind about participation 			
Intervention discontinued (first/second dose not given despite participant remaining pregnant)	 Participant withdrawal after randomisation Birth plan changed to normal vaginal birth before study drug administration Participant didn't attend first or second visit Severe reaction to first dose, second dose not given 			
Major non-compliance with intervention	 Study drug/s given outside the allowed window (two doses given but <20 hours or >28 hours apart) Incorrect route of administration 			
No neonatal blood sugar measurements	Ward staff unaware, and the baby did not receive glucose testing in the first 12 hours of life			
Incorrect intervention	The study drug kit number administered was different to the kit number allocated by the randomisation system			
Randomised in wrong stratum	 Incorrect entry of EDD/GA/pregnancy type (singleton/twin) during randomisation Incorrect calculation of GA due to coding error - feasibility study 			
Other	Written consent obtained after randomisation			

Withdrawal of Consent (Complete CRF 12)

The Participant Withdrawal Form is to be completed **only when the participant explicitly requests withdrawal** or at the discretion of the investigator.

- Full withdrawal if no further study participation, data collection or follow-up contact
- **Reduced participation** declined some outcome assessments but continued collection of data +/- no further follow-up contact (If 6-week postnatal questionnaires are not yet sent, select 'No' in CRF5 Maternal Outcome)
