

# Auckland Centennial Music Festival Award

## Description

In the year 1940, the Auckland Provincial Centennial Council donated to the Council a sum of £Stg2,400, of which £Stg800 represented the profits from the Centennial Music Festival held in Auckland in 1940, to establish Music Scholarships.

## Selection process

- Nomination is made to the Scholarships Office
- The Award is made by the University of Auckland Council on the recommendation of the Selection Committee

## Regulations

1. The Award will be known as the Auckland Centennial Music Festival Award.
2. One Award will be made annually for a period of up to one year and will be of the value of \$1,400.
3. To be eligible for Award consideration, candidates must have qualified by audition to enrol full-time in the first year of a Bachelor of Music (BMus) or BMus conjoint degree in Creative Practice: Classical or Creative Practice: Jazz.
4. The basis of selection will be the outcome of an audition for admission to the Bachelor of Music.
5. The Award will be made by the University of Auckland Council on the recommendation of a Selection Committee comprising the Head of the School of Music (or nominee) and two members of academic staff of the School of Music nominated by the Head of School.
6. To be paid the Award, the awardee must be enrolled full-time in the first year of a BMus or BMus conjoint degree in Creative Practice: Classical or Creative Practice: Jazz.
7. The Award will be paid in one lump sum in Semester One, as soon as is practical after confirmation of the awardee's enrolment, that is, after the final date on which a student may add or delete courses without incurring a late enrolment fee.
8. The Award may be held concurrently with any other scholarship, award or grant as long as the regulations for that scholarship, award or grant permit and the University of Auckland Council is informed and approves. It is the responsibility of the awardee to declare to the Scholarships Office all other scholarships, awards or grant funding received and for which the awardee receives payment while also in payment for this Award.

9. The University of Auckland Council is not obliged to make an award if it is determined there is no candidate that meets the criteria and/or no candidate of sufficient merit.
10. The University of Auckland Council can amend or vary these regulations provided that there is no departure from the main purpose of the Award.
11. Notes [I]-[II] below are deemed to be regulations.

## Notes

---

- I. Payments under the terms of this Award remain tax-free as long as they are used directly for payment of costs associated with an awardee's programme of study and to assist the awardee with living costs while studying. Failure to comply with this regulation will result in the termination of the Award.*
- II. Awardees will be required to comply with the regulations for the Award and will notify the Scholarships Office of any change in their enrolment or funding status. The University of Auckland may, in the event that it can be established that an awardee is not complying with these regulations, terminate the Award and require repayment of the funds received.*
