Description

The Scholarship was established in 2024 and is funded by the Faculty of Creative Arts and Industries.

The main purpose of the Scholarship is to support international students enrolled in Part II and subsequently Part III of a Bachelor of Architectural Studies at Waipapa Taumata Rau, University of Auckland as part of a formalised articulation agreement with partner institution the University of Economics Ho Chi Minh City (UEH) Institute of Smart City and Management (ISCM).

Selection process

- Nomination is made to the Scholarships Office
- The Award is made by the University of Auckland Council on the recommendation of the Selection Committee

Regulations

- 1. The Scholarship will be known as the Faculty of Creative Arts and Industries BAS Award for UEH Partnership Students.
- 2. Up to three Awards will be made annually each for a period of up to two years and will comprise a contribution towards compulsory tuition fees of up to \$21,000 each, approximately \$10,500 per annum.
- 3. To be eligible for Award consideration, an applicant must i) be an international student (see Note II), excluding study abroad or exchange students, ii) have been referred to Waipapa Taumata Rau, University of Auckland by the University of Economics Ho Chi Minh City (UEH) Institute of Smart City and Management (ISCM), and iii) be enrolled or enrolling full-time in Part II of a Bachelor of Architectural Studies (BAS) at Waipapa Taumata Rau, University of Auckland.
- 4. The basis of selection will be academic achievement as assessed by results obtained from study at ISCM.
- 5. The Scholarship will be awarded by the University of Auckland Council on the recommendation of a Selection Committee comprising Associate Dean (International) of the Faculty of Creative Arts and Industries (or nominee), the

- Head of the School of Architecture and Planning (or nominee) and one member of Academic Staff from the Faculty of Creative Arts and Industries nominated by the Head of the School of Architecture and Planning.
- 6. The Scholarship will be paid as a contribution towards compulsory tuition fees in Semester One in each year of study, as soon as is practical after confirmation of the awardee's enrolment (that is, after the final date on which a student may add or delete a course without incurring a late enrolment fee.
- 7. To be paid the Award, awardees must be enrolled full-time in Part II of a BAS in the Faculty of Creative Arts and Industries at Waipapa Taumata Rau, University of Auckland.
- 8. As a condition of tenure, awardees will be required to enrol full-time for at least two semesters of study in the Faculty of Creative Arts and Industries at Waipapa Taumata Rau, University of Auckland (see Note IV).
- 9. The Scholarship may not be held concurrently with a University of Auckland Transnational Education Partner High Achiever Award, or any other scholarships, grant, award or bursary funded by Waipapa Taumata Rau, University of Auckland. However, it may be held with any other scholarship, award or grant as long as the regulations for that scholarship, award or grant permit and the University of Auckland Council is informed and approves. It is the responsibility of the awardee to declare to the Scholarships Office all other scholarships, awards or grant funding received and for which the awardee receives payment while also in payment for this Scholarship.
- 10. The University of Auckland Council has the power to terminate or suspend a scholarship if it receives a report of unsatisfactory progress by a Scholar from the Associate Dean (International) of the Faculty of Creative Arts and Industries.
- 11. The University of Auckland Council is not obliged to make an award if it is determined there is no candidate that meets the criteria and/or no candidate of sufficient merit.
- 12. The University of Auckland Council, in consultation with the Faculty of Creative Arts and Industries, can amend or vary these regulations provided that there is no departure from the main purpose of the Scholarship.
- 13. Notes [I]-[V] below are deemed to be Regulations.

Notes

- I. Compulsory tuition fees are only those related to the relevant programme of study, plus Student Services Fee.
- II. International students are students who are neither citizens, permanent residents nor resident visa holders of New Zealand or Australia.
- III. The Award may not be deferred until the following semester. Where a Scholar is unable to take up the Award in the semester awarded, their offer will lapse.
- IV. Awardees who take up this Award but who do not complete at least two semesters of study at Waipapa Taumata Rau, University of Auckland or who withdraw their enrolment in any semester after payment has been made, will normally be required to pay back the full sum of monies received.
- V. Awardees will be required to comply with the regulations for the Scholarship and must notify the Scholarships Office of any change in their enrolment or funding status. Waipapa Taumata Rau, University of Auckland may, in the event that it can be established that an awardee is not complying with these regulations, terminate the Scholarship and require repayment of the funds received from the date of the breach.
- VI. These regulations are subject to Senate and Council approval.
