Description

The Scholarship was established in 2018 and is funded by Colliers in memory of Peter Kermode. Peter completed the Wellesley Programme (now known as the Tertiary Foundation Certificate) in 2001, went on to study a Bachelor of Property at the University of Auckland and became a highly respected and successful Commercial Property Broker at Colliers.

The main purpose of the Scholarship is to support a student in their first year of study after graduating from the University of Auckland Tertiary Foundation Certificate (TFC) programme. The successful applicant will have demonstrated qualities in their TFC year that were characteristic of Peter Kermode: empathy and an understanding of others, grit, diligence, commitment, and ability to overcome adversity.

Selection process

- Application is made to the Scholarships Office
- A Selection Committee assesses the applications
- The Scholarship is awarded by the University of Auckland Council on the recommendation of the Selection Committee

Regulations

1. The Scholarship will be known as the Peter Kermode Scholarship.
2. One Scholarship will be awarded annually, for a period of up to one year, and will be of the value of up to \$5,000.
3. To be eligible for Scholarship consideration, an applicant must be i) a New Zealand Citizen or Permanent Resident (see Note II), ii) currently enrolled in the University of Auckland Tertiary Foundation Certificate (TFC) programme, and iii) intending to enrol full-time in an undergraduate degree at Waipapa Taumata Rau, University of Auckland in the following year.
4. The basis of selection will be academic ability as assessed by results to date in the TFC programme and a reference from an academic staff member from the TFC programme, and financial need as assessed by a personal statement and the criteria at Note III. The academic reference must outline how the applicant has demonstrated the qualities of

empathy and an understanding of others, grit, diligence, commitment, and an ability to overcome adversity during their TFC year.

5. The Scholarship will be awarded by the University of Auckland Council on the recommendation of a Selection Committee comprising the Programme Coordinator of the Tertiary Foundation Certificate programme (or nominee), one representative from Colliers and one representative from the Kermode family.
6. The Scholarship will be paid as a contribution towards compulsory tuition fees in two equal instalments in Semesters One and Two, as soon as is practical after confirmation of the awardee's enrolment (that is, after the final date on which a student may add or delete courses without incurring a late enrolment fee).
7. To be paid the Scholarship, the awardee must be enrolled full-time in an undergraduate degree at Waipapa Taumata Rau, University of Auckland. To be paid the second instalment, the applicant must achieve a grade point average (GPA) of at least 3.50 (equivalent to a C+ average) in their first semester of study in their undergraduate degree programme. (see Note IV).
8. The Scholarship may not be held concurrently with a University of Auckland Academic Potential Scholarship. However, it may be held with any other scholarship, award or grant as long as the regulations for that scholarship, award or grant permit and the University of Auckland Council is informed and approves. It is the responsibility of the awardee to declare to the Scholarships Office all other scholarships, awards or grant funding received and for which the awardee receives payment while also in payment for this Scholarship.
9. The University of Auckland Council, in consultation with the donor, has the power to terminate or suspend a scholarship if it receives a report of unsatisfactory progress by a Scholar from the relevant Head of Department or School.
10. The University of Auckland Council is not obliged to make an award if it is determined there is no candidate that meets the criteria and/or no candidate of sufficient merit.
11. The University of Auckland Council, in consultation with the donor, can amend or vary these regulations provided that there is no departure from the main purpose of the Scholarship.
12. Applications close with the Scholarships Office on 6 November in the year preceding the award.
13. Notes [I]-[VIII] below are deemed to be Regulations.

Notes

- I. Tuition/Compulsory fees are only those related to the relevant programme of study, plus Student Services Fee.*
- II. New Zealand Permanent Residents have been granted a Permanent Resident Visa by Immigration New Zealand. For more information visit <https://www.immigration.govt.nz/new-zealand-visas/already-have-a-visa/becoming-a-permanent-resident>.*
- III. Financial need will be determined by a range of factors including eligibility for a StudyLink Student Allowance, and personal and financial circumstances.*
- IV. Except in cases where there are compelling medical reasons or adverse personal circumstances beyond a student's control, the uptake of scholarships cannot be deferred. Students who are offered a Peter Kermode Scholarship but who do not take it up in the year of offer may request that their application be reconsidered in the intake of applications for the year immediately following. Deferral requests must be made in writing to the Scholarships Office.*
- V. If a student enrolls at another tertiary institution in New Zealand or overseas, the scholarship will be forfeited.*
- VI. Awardees must be enrolled continuously in their programme of study. Deferrals for students who have already commenced their degree will not usually be approved unless there are compelling medical or adverse personal circumstances beyond the student's control. Deferral requests must be made in writing to the Scholarships Office.*
- VII. The awardee's GPA is based on all the courses they undertake in each semester of study.*
- VIII. Awardees will be required to comply with the regulations for the Scholarship and must notify the Scholarships Office of any change in their enrolment or funding status. Waipapa Taumata Rau, University of Auckland may, in the event that it can be established that an awardee is not complying with these regulations, terminate the Scholarship and require repayment of the funds received from the date of the breach.*
