## Description

The Warren Trust Award was established in 2012 by the Warren Architects Education Charitable Trust.

The main purpose of the Award is to encourage and reward student achievement in, and commitment to, architectural studies in New Zealand.

## Selection process

- Nomination is made to the Scholarships Office
- The Award will be made by the University of Auckland Council upon the recommendation of the Head of the School of Architecture and Planning

## Regulations

1. The Award will be known as the Warren Trust Award.
2. Up to three Awards will be made annually and will be of the value of \$5,000 each.
3. To be eligible for Award consideration, a candidate must i) have met the requirements to graduate with a Bachelor of Architectural Studies degree, and ii) be intending to enrol in a Master of Architecture (Professional), Master of Architecture (Professional) and Heritage Conservation, Master of Architecture (Professional) and Urban Design or Master of Architecture (Professional) and Urban Planning degree at the University of Auckland in the year following completion of their Bachelor of Architectural Studies degree.
4. The Award will be made to the three students who achieved the highest grade point average (GPA) across all courses taken in the third year of the Bachelor of Architectural Studies in the preceding year.
5. The Award will be made by the University of Auckland Council on the recommendation of the Head of the School of Architecture and Planning (or nominee).
6. The Award will be paid in one instalment in Semester One, as soon as is practical after confirmation of the awardee's enrolment (that is, after the final date on which a student may add or delete courses without incurring a late enrolment fee).
7. To be paid the Award, awardees must be enrolled full-time in the first year of a Master of Architecture (Professional),

Master of Architecture (Professional) and Heritage Conservation, Master of Architecture (Professional) and Urban Design or Master of Architecture (Professional) and Urban Planning degree.

8. The Award may not be co-tenured with the Murray Wren Masters Scholarship in Architecture, however, it may be held with any other scholarship, award or grant as long as the regulations for that scholarship, award or grant permit and the University of Auckland Council is informed and approves. It is the responsibility of the awardee to declare to the Scholarships Office all other scholarships, awards or grant funding received and for which the awardee receives payment while also in payment for this Award.
9. The University of Auckland Council is not obliged to make an award if it is determined there is no candidate that meets the criteria and/or no candidate of sufficient merit
10. The University of Auckland Council can amend or vary these regulations in consultation with the Warren Architects Education Charitable Trust, provided there is no departure from the main purpose of the Award.
11. Notes [I]-[III] below are deemed to be regulations.

## Notes

- I. The tax-free status of this Award is under current legislation. The University of Auckland cannot guarantee this tax-free outcome.*
- II. Payments under the terms of this Award remain tax-free as long as they are used for the payment of costs associated with an awardee's programme of study and/or to assist the awardee with living costs while studying. Failure to comply with this regulation will result in the termination of the Award.*
- III. Awardees will be required to comply with the regulations for the Award and must notify the Scholarships Office of any change in their enrolment or funding status. Waipapa Taumata Rau, University of Auckland may, in the event that it can be established that an awardee is not complying with these regulations, terminate the Award and require repayment of the funds received.*
