

# The Kate Edger Educational Charitable Trust Dame Dorothy Winstone Doctoral Completion Award

#### **Description**

The Award was established in 2012 and is funded by The Kate Edger Educational Charitable Trust.

The main purpose of the Award is to assist a woman graduate who has completed a minimum of three years of full-time study or six years of part-time study towards a PhD or named Doctorate, to have at least four months free of employment and to remain or become a full-time student, in order to make substantial progress towards completion of a PhD or named Doctorate qualification. The Award is intended for students studying full-time towards a qualification; however, the Trustees recognise that health conditions or impairments can limit a person's ability to study full-time and have extended the Award in 2023 to include part-time study on a case-by-case basis.

## **Selection process**

- Application is made to the Scholarships Office
- The Kate Edger Educational Charitable Trust assesses the applications
- The Award is made by the University of Auckland Council on the recommendation of The Kate Edger Educational Charitable Trust

## Regulations

- 1. The Award shall be known as The Kate Edger Educational Charitable Trust Dame Dorothy Winstone Doctoral Completion Award.
- 2. Awards will be made three times a year, for a period determined by The Kate Edger Educational Charitable Trust, and will be of the value of up to \$16,000 each.
- 3. To be eligible for Award consideration, an applicant must i) be a woman, ii) be a New Zealand Citizen or Permanent Resident (see Note II), iii) have completed a minimum of 30 months of full-time study or 60 months of part-time study towards a PhD or named Doctorate at the time of application for the Award and must intend to enrol full-time at Waipapa Taumata Rau, University of Auckland for at least four further months to complete their PhD or named

Doctorate. Applicants who have completed more than 42 months of full-time equivalent study towards their PhD or named Doctorate by the application date are not eligible for consideration. Students with health conditions or impairments that limit their ability to study full-time may apply to hold the Award on a part-time basis (see Regulation 4 and Note III). A grade point average (GPA) or grade point equivalent (GPE) of at least 7.00 (6.50 for Māori candidates or Pacific candidates) in their qualifying programme is required for Award consideration (see Note IV).

- 4. The basis of selection will be academic merit as assessed by the GPA/GPE calculated over the qualifying programme for the PhD or named Doctorate, and the applicant's academic achievements, research qualifications and research plans, and two academic references (see Note V). Applications must include verification from the Head of Department or School in which the applicant is enrolled, a brief abstract of the doctoral research, and a budget outlining how the award would be spent (see Note VI). Applications from students studying part-time must include documentation supporting their reasons for studying part-time (see Notes III and VII).
- 5. The Award will be made by the University of Auckland Council on the recommendation of The Kate Edger Educational Charitable Trust.
- 6. The Award will be paid in one instalment upon acceptance. Payment will be pro-rated on a case-by-case basis for part-time study.
- 7. To be paid the Award, awardees must be enrolled in a PhD or named Doctorate at Waipapa Taumata Rau, University of Auckland.
- 8. The Award may not be held concurrently with any other scholarship, award or grant of equal or higher value. It may be held with any other scholarship, award or grant as long as the regulations for that scholarship, award or grant permit and the University of Auckland Council and The Kate Edger Educational Charitable Trust are informed and approve. It is the responsibility of the awardee to declare to the Scholarships Office all other scholarships, awards or grant funding received and for which the awardee receives payment while also in payment for this Award.
- 9. The amount of additional and paid work a Scholar may undertake either inside or outside the University shall not exceed a total of 10 hours per week (see Note VIII).
- 10. The University of Auckland Council is not obliged to make an award if it is determined there is no candidate that meets the criteria and/or no candidate of sufficient merit.
- 11. Payments under the terms of this Award remain tax-free as long as they are used directly for the payment of costs associated with an awardee's programme of study and/or to assist the awardee with living costs while studying (see Note I). Failure to comply with this regulation will result in the termination of the Award.
- 12. The University of Auckland Council, in consultation with The Kate Edger Educational Charitable Trust, can amend or vary these Regulations provided that there is no departure from the main purpose of the Award.
- 13. Applications close with the Scholarships Office on 15 April and 15 July in the year of the award, and 14 November in the year preceding the award. Doctoral students should apply at least six months prior to the maximum submission date for their doctoral programme.
- 14. Notes [I]-[XII] below are deemed to be regulations.

#### **Notes**

- I. The tax-free status of this Award is under current legislation. The University of Auckland cannot guarantee this tax-free outcome.
- II. New Zealand Permanent Residents have been granted a Permanent Resident Visa by Immigration New Zealand. For more information visit https://www.immigration.govt.nz/new-zealand-visas/already-have-a-visa/becoming-a-permanent-resident.
- III. Waipapa Taumata Rau defines disability as any physical, psychological, cognitive or sensory impairment which, in interaction with social and systemic barriers, restricts a person's full and effective participation in university life on an equal basis with others.
- IV. Where a qualifying programme is an undergraduate honours degree (or equivalent undergraduate degree or integrated undergraduate and postgraduate degree), the GPA/GPE will be calculated over the final two years of full-time study (or equivalent) in the programme. In all other cases, the GPA/GPE will be calculated over the entirety of

- the programme.
- V. References must be from two academic staff members at Waipapa Taumata Rau, University of Auckland, not related to the applicant, of which one must be the applicant's Doctoral supervisor. References must reflect the referee's opinion of the applicant's scholastic ability, commitment, and motivation for completing the qualification within the next 12 months, and any other information deemed relevant to the application.
- VI. Verification from the Head of School or Department must confirm that the applicant has received official approval to undertake the research work described in this application and fulfils the requirements for enrolment as a full-time student. The abstract will be no more than 500 words and must include the aims, objectives, and significance of the research. The budget may include, but is not limited to, living costs, equipment, materials, field work, software, travel, or producing publications.
- VII. Examples of supporting documents include, but are not limited to, a letter of support from a disability service provider, the Students with Disabilities office, or your general practitioner
- VIII. Paid work undertaken as part of an approved University of Auckland Internship is not counted towards the 10 hours a week of additional and paid work that a Scholar may undertake while in receipt of an award.
- IX. On completion of her degree, the awardee will be required to submit a brief report endorsed by their Supervisors, to the Awards Convener of The Kate Edger Educational Charitable Trust.
- X. Any publications arising from the recipient's research should acknowledge the Award received from The Kate Edger Educational Charitable Trust.
- XI. Awardees will be required to comply with the regulations for the Award and must notify the Scholarships Office of any change in their enrolment, employment or funding status. Waipapa Taumata Rau, University of Auckland may, in the event that it can be established that an awardee is not complying with these regulations, terminate the Award and require repayment of the funds received.
- XII. The Award is also open to eligible students from other approved institutions in the Auckland area, who should apply directly through The Kate Edger Educational Charitable Trust.
