# LAW 498 and 499 2018 Guidelines

Students must complete either LAW 498 or LAW 499 to meet the compulsory requirements of the LLB/LLB(Hons) degree.

LAW 499 is only available as an option to students admitted to Part III **before 2017** and will be discontinued at the end of semester two, 2018. Any student who has not completed the requirements of LAW 499 by December 2018 must then complete LAW 498.

Students of the LLB and LLB (Hons) must enrol in LAW 498 or 499 to coincide with <u>the final semester</u> of study on the LLB (and before the dissertation if completing the Honours programme).

If, after you enrol in LAW 498 or 499, you have not completed all requirements <u>within two semesters</u> your transcript will reflect a 'DNC'. (Summer School does not count for these purposes). For example if you had enrolled in LAW 498 or 499 in the first semester of 2017 and had not completed the course requirements by the end of the first semester of 2018 then your transcript will include a DNC.

Always check with your Student Adviser if you are unsure of the programme requirements which apply to you.

Please be aware that although every reasonable effort is made to ensure accuracy, the information in these guidelines is subject to alteration.

# LAW 498 – Advanced Legal Research, Writing and Communication (0 points) requirements in 2018

1. You must obtain a pass in a moot above Part II. Any moot that is optional (not part of course requirements) will qualify including the General, Family, Māori Issues, Pacific and some competition moots.\*

#### AND

- 2. You must complete a single piece of sustained legal writing of at least 4000 words which satisfies the assessors on an elective course. This could be satisfied in various ways, including:
  - LAW 456 Supervised Research
  - PILO of at least 4000 words
  - LAWGENRL 405 or LAWGENRL 447 course report
  - Research Essay for a 15 or 30 point masters course taken within the LLB
  - Honours Seminar Paper
  - Honours Dissertation
  - Any other single piece of writing of at least 4000 words.

\* In 2018 the following competition moots qualify: AWLA, Stout and Greg Everard.

A moot must be judged, or the judging/marking be moderated, by a member of the (Law Faculty) Academic Staff. Moots organised and/or judged by students, or by practitioners without direct academic oversight will not qualify.

#### Grading in LAW 498

No letter grades are awarded: LAW 498 is graded with either *Completed (CPL)* or *Did Not Complete (DNC)*

# LAW 499 – Legal Practice (0 points) requirements in 2018:

You must complete the compulsory Part III Moot (General, Family, Maori Issues or Pacific Issues) and also pass *five single pieces of legal writing of at least* 1,500 words each in any law elective courses.

#### A single piece of legal writing of at least 1,500 words may include:

- An opinion, research essay, or other written assignment in any 10, 15, and/or 20-point law elective course
- A single piece of legal research and writing of at least 1,500 words for an internally-assessed elective course\*
- A research paper in lieu of exam (PILO) \*
- A 10,000-word Supervised Research paper of (LAW 456)

Of the required *five single pieces of legal writing,* up to <u>two</u> may be substituted by successfully completing the following alternatives:

- Community Placement
- One subject-related or competitive moot (incl. Stout Shield)
- Two subject-related or competitive moots (incl. Stout Shield) if no Community Placement has been counted

#### \*provided you complete all assignments in the course

\*Where a PILO and opinion are completed in the *same* course both may be credited toward LAW 499 provided they are on different topics, and subject to other guidelines.

#### The following do **NOT** qualify towards LAW 499:

- a) AULR editorial work or other roles
- b) EJP
- c) Model UN, World Client Interviewing and other competitions
- d) Honours seminar papers and dissertations (although may count in special circumstances where student has discontinued Honours and has approval from AD(Academic)).

#### Grading in LAW 499

No letter grades are awarded: LAW 499 is graded with either *Completed (CPL)* or *Did Not Complete (DNC)* 

#### These are the Five Alternative Options for completing LAW 499:


- **Option 1:**Part III Moot completion AND<br/>A pass in each of 5 *single pieces of legal writing of at least 1,500 words* in law elective courses
- Option 2: Part III Moot completion AND A pass in each of 4 *single pieces of legal writing of at least 1,500 words* in law elective courses PLUS Community Placement
- Option 3:Part III Moot completion ANDA pass in each of 4 single pieces of legal writing of at least 1,500 words in law elective courses PLUSsatisfactory completion of a subject, or a competitive moot
- Option 4: Part III Moot completion AND A pass in each of 3 *single pieces of legal writing of at least 1,500 words* in law elective courses PLUS Community Placement AND Satisfactory completion of a subject moot OR a competitive moot
- **Option 5:** Part III Moot completion and A pass in each of 3 *single pieces of legal writing of at least 3,000 words* in law elective courses PLUS satisfactory completion of two moots – subject and/or competitive

#### **CHANGE TO REQUIREMENTS FROM 2016**

The previous requirement to complete 'a single piece of writing of at least 3000 words' has now been replaced by the requirement to complete a single piece of writing (other than a take-home test/exam) of at least **1500** words in an elective course. To receive credit for this course you must complete all the other requirements of the course.

Where an elective course includes more than one written assignment with a minimum of 1500 words, only one assignment will be credited towards LAW 499.
