

LAW 498 2019 Guidelines

LAW 498 – Advanced Legal Research, Writing and Communication (0 points)

LAW 498 is a compulsory requirement of the LLB/LLB(Hons) degree

1. Every LLB and LLB (Hons) student **must enrol** in and complete the requirements of LAW 498.
2. LAW 498 must be completed as part of **the final semester** of study on your LLB programme. Honours students must complete it before the dissertation.
3. If, after you enrol in LAW 498, you have not completed all requirements **within two semesters** you will receive a 'DNC' on your transcript. Summer School does not count in this calculation. So for example, if you enrolled in LAW 498 in semester one of 2019 but do not complete the course requirements by the end of semester one in 2020 then your transcript will include a DNC for this course.
4. Check with your Student Adviser if you are unsure about any of the course requirements for LAW 498.

NOTE: Every reasonable effort is made to ensure the accuracy of information set out in these guidelines, but details are subject to change at the discretion of the course directors.

LAW 498 – Advanced Legal Research, Writing and Communication (0 points) requirements in 2019

1. You must obtain a pass in a moot **above Part II**. Any moot that is optional (i.e. not part of course requirements) will qualify including the General, Family, Māori Issues and Pacific moots. Some, but not all, competition moots *may* also qualify.*

AND ALSO

2. You must complete a single piece of **sustained legal writing of at least 4000 words** which satisfies the assessors on an elective course. This can be satisfied in various ways, including:
 - LAW 456 Supervised Research
 - PILO of at least 4000 words
 - LAWGENRL 405 or LAWGENRL 447 report
 - Research Essay for a 15 or 30 point masters course taken as part of your LLB programme
 - Honours Seminar Paper
 - Honours Dissertation
 - Any other single piece of writing of at least 4000 words. Please refer to the schedule below to identify course assessments which comply with LAW 498 requirements

* In 2019 the following competition moots qualify: Greg Everard, Stout Shield and some International Moots at the discretion of the Course Director. If you wish to have your participation in any of these competition moots credited please email lawacademicservices@auckland.ac.nz. For a competition moot to qualify for LAW 498 it must be judged, or the judging/markings moderated, by a member of the (Law Faculty) Academic Staff. Moots organised and/or judged by students, or by practitioners without direct academic oversight will not qualify.

Grading in LAW 498

No letter grades are awarded: LAW 498 is graded with either *Completed (CPL)* or *Did Not Complete (DNC)*
