Terms and conditions of enrolment and fees

Procedures for tamaiti/child /childcare fees charged & FAQ's

<p>What do I need to have in place before my tamaiti/child can begin at the service, and when can I start?</p>	<p>When all documents are received your tamaiti/children are loaded into our childcare software system and fees will begin being charged according to your start date. We do ask that all childcare fees are paid two weeks in advance to cover the two-week notice period.</p>
<p>How are tamaiti/childcare fees charged, what is being charged and when?</p>	<p>At the University of Auckland (UOA) childcare centres and Te Kōhanga Reo we charge regular fees for all absences included statutory holidays. The only time UOA does not charge regular fees is over the two-week Christmas and New Year closure period – these dates are given around October each year. Regular fees are charged when your child is sick or absent unless stated otherwise in the holiday and absence procedure. Fees are to be paid two weeks' in advance by Automatic Payment, Internet Banking, EFTPOS or Salary Sacrifice if UOA staff. Failure to keep fees up to date may result in your enrolment ending, and the debt being passed on to a collection agency, for which the whānau/family will be responsible for any associated costs incurred. <i>We do value the relationships we have with whānau/family and would rather you talk to us if you are struggling to meet your payments, there may be options available to you that you may not be aware of.</i></p>
<p>Do you provide make up days and changes to enrolment days and times?</p>	<p>We do not provide make up days of any kind. Changes to enrolled days and times are possible if they are given with two weeks' notice in writing to Centre Leaders/Kaiwhakahaere – this can could be via email.</p>
<p>Do you have a notice period?</p>	<p>Our services require a two-week notice period to make any changes to enrolments including cancellation of enrolment. This includes transfers to school.</p>
<p>Is there a minimum booking?</p>	<p>There is a minimum booking time of 2 days per week or 2 sessions of 4 hours, in either the morning or afternoon – dependant on the centre structure. <i>Please note that "sessions" are only available to student whānau/families.</i></p>
<p>Is there a late fee if I collect my tamaiti/child after their booked hours?</p>	<p>We will always try and support our whānau/family where we can, if you are running late please let us know, if it becomes a habit, you may be asked to pay a late fee to cover some of the overtime we have to pay our kaiako.</p>
<p>Do you support WINZ subsidies and other support grants.</p>	<p>Absolutely! We love these to be completed before your tamaiti/child begins at our centre but understand circumstances change over their journey. We will help you with all the paperwork you need. Come and talk to us or check out the WINZ website</p>

Do you provide statements?	We do, these arrive in your email inbox each week. You are normally billed two weeks in advance to cover the cancellation period. If you are not receiving them, please just let us know.
Do you provide nappies?	<p>Only one of our centres provides nappies – this is Te Ako o Te Tui in Grafton.</p> <ul style="list-style-type: none"> • The nappy charge of \$4.00 per week. • This will be charged to your account on your booked days.

Procedures for holidays and discounts

Sibling discount

A discount of 10% is offered to whānau with two or more tamariki/children at UOA services.

- Multiple child discount only applies to the youngest of the children and only until the child turns three. Once the additional tamaiti/child turns three no ongoing discounts apply, as they will be accessing the 20-hour ECE subsidy.
- When the older of the sibling leaves, the multiple sibling discount will also end. If the tamaiti/child is still under the age of three, regular fees will then be charged.
- The multiple tamariki/children discount is only applied to one tamaiti/child. If you have three or more tamariki/children, this will be case-by-case and to be discussed with the ECE General Manager via the Kaiwhakahaere or Centre Leader.

Holidays and Absences

University of Auckland Students

- For absences of less than a week, full fees are payable.
- If a child is away for a full week and up to three weeks, a holding fee will be charged, which is usually half the normal fee. Application is required in writing at least one week in advance.
- Absences in excess of the three weeks will require payment of full fees to retain your tamaiti/child's place as we will lose the Government funding after 15 days.
- If absences are not advised in advance, full fees may be charged.
- Fees will not be charged for absences during the months of December and January as long as notification of a child's absence has been received.
- Where a public holiday falls on a day a tamaiti/child is enrolled, the parent shall be charged for that day - with the exception of Easter Tuesday, which is a University holiday.

University of Auckland Employees

- For absences of less than a week, full fees are payable.
- If a child is away for a full week and up to three weeks, a holding fee will be charged, which is half the normal fee. Application is required in writing at least one week in advance.
- Absences in excess of three weeks will require payment of full fees to retain your tamaiti/child's place.
