Accounting

Gain advanced knowledge in performance measurement and decision-making. Select from a range of financial and management accounting courses and study research methodology techniques while developing your skills in critical interpretation in preparation for a short dissertation. Prepare for more specialised roles in a chartered accountancy practice, industry or the public sector, or a business consultant or financial manager role in a manufacturing, service or consultancy organisation. An academic career is also an option for those who pursue further study and research.

Finance

Learn about the capital markets and the financing decisions facing organisations. Build your understanding of concepts such as good corporate governance, investments, valuation theory, asset pricing, market micro-structure, capital structure and dividend policy, riskhedging and liquidity management. Studying finance at postgraduate level can lead you to more senior or specialised career roles such as academic, chief financial officer, corporate advisor or valuer, multinational funds manager, or portfolio manager.

ENTRY REQUIREMENTS

- Bachelor of Commerce or equivalent with Accounting or Finance major with a grade point equivalent of <u>at least 7.0</u> in 45 points in Stage III courses required for the chosen major.
- Maths/ Stats 208 or equivalent course approved by the Head of Department
- For international students, the minimum English requirement is an overall IELTS academic score of 6.5 with no band less than 6.0, or an approved equivalent





MASTER OF COMMERCE

 A 12-15 months programme designed to prepare students for specialist positions in the public and private sector

Entry Requirements:

- Bachelor of Commerce or equivalent with Accounting or Finance major with a grade point equivalent of <u>at least 6.5</u> in 45 points in Stage III courses required for the chosen major.
- Maths/ Stats 208 or equivalent course approved by the Head of Department
- For international students, the minimum English requirement is an overall IELTS academic score of 6.5 with no band less than 6.0, or an approved equivalent

Guaranteed Postgraduate Scholarships (value: \$13,130 tax free + compulsory fees)

All you need to do is apply for admission and the University will automatically consider your eligibility for a scholarship.
